Once you have submitted your email and created a password you will be required to submit proof of residency and our team will verify status in 24 to 48 hours.

To submit proof of residency, click on **PROILE** then scroll down and click **Proof of Res | Doc.** Please upload your **government issued photo Id** with your Hillcrest address on it. **PLEASE NOTE THAT PROOF OF RESIDENCY CAN ONLY BE UPLOADED WHEN USING A COMPUTER AND NOT THE PLAYBYPPOINT APP.**

Once your proof of residency has been verified and accepted then you will be able to purchase the annual membership to reserve the courts. At this time, you can also download the Playbypoint App to book a court.

Hillcrest Residents will need to submit proof of residency and our team will verify status in 24 to 48 hours. Parkview at Hillcrest registered residents will not need to submit proof of residency.

Parkview at Hillcrest Tennis Courts/Center Rules & Regulations

The Tennis Center and Court hours are from 8:00 AM – 9:00 PM

1. The tennis courts are for the use of the members of Parkview at Hillcrest and Hillcrest only. Clubhouse FOB's must be available during the use of the facility.
2. Any person using the tennis courts does so at their own risk.
3. Children less than 13 years of age must always be supervised by an adult 18 years of age, or parent/legal guardian with a valid ID.
4. Residents are permitted three (3) guests per household.
5. These courts may not be used for any purpose other than the game of tennis, and its variants
6. Reservations are limited to one (1) hour of use.
7. Proper tennis attire and non-marking athletic shoes are required.
8. Glass, food, and alcoholic beverages are not permitted in the court area. Plastic beverage containers are permitted. Members are responsible for keeping the courts clean.
9. No chairs are allowed on the court surfaces.
10. Amplified music is prohibited in the Tennis Center and Courts. All cell phones and other electronic devices must be silenced. All cell phone conversations must take place outside the tennis courts.
11. Boisterous or profane language, spitting and expectorating by players or spectators is prohibited on or near the courts.
12. No motorized vehicles, bicycles, skates, or scooters of any kind are allowed on the Courts or within the Tennis Center. Bikes must use the exterior bike racks, if available.
13. **Personal Trainers/Instructors** (private lessons) are permitted only for Parkview at Hillcrest and Hillcrest Residents and only on a single court. Class lessons are not allowed at this time, and the instructor must first register with the Management Office and must provide proof of current Licensure and their Certificate of Insurance.
14. Violation of the Rules & Regulations will forfeit the right to be a member. Members will be financially responsible for any damages caused to the Tennis Courts or Tennis Center by them or their guests.

HILLCREST RESIDENTS' MEMBERSHIP

- To become a member of the Parkview at Hillcrest tennis courts, you must show proof of residency (Driver License or ID Card). Management will verify proof before your membership is accepted.
- All memberships are for a period of one (1) year.
- All sales are final.
- Online reservations are required.
- Members are permitted three (3) guests per household.
- Reservations are limited to one (1) per day for one (1) hour.
- Personal Trainers/Instructors (private lessons) are permitted only for members and only on a single court. Class lessons are not allowed. All instructors must first register with the Management Office and must provide proof of current Licensure and their Certificate of Insurance.
- All members must agree to abide to the Parkview at Hillcrest Tennis Courts Rules & Regulations.
- Violation of the Rules & Regulations will forfeit the right to be a member. Members will be financially responsible for any damages caused to the Tennis Courts or Tennis Center by members or their guests.
